The expired amendment placed temporary restrictions on these civil suits by limiting them to apply only to movers who were unregistered, newly licensed, poorly rated, or who had their license revoked, but these limitations no longer apply, and state attorneys general may now bring 17 suits against any mover. If a resident of a state is adversely affected by the actions of a carrier or broker, the state attorney general may sue on the residents behalf to enforce the federal laws and regulations with which the carrier or broker was required to comply. Penalties imposed and collected by these lawsuits would be paid to the federal government, not to the state or the individual consumer. For any civil action initiated by a state attorney general, the state must 18 serve written notice to DOT or the Surface Transportation Board (STB), whichever agency has jurisdiction....
